If you want to have a Licensed Bar at the Village Hall the procedure is as follows:

Request a Licensed bar on the Hall Booking Form

At least one months notice is required before the event

You will be advised within one week after receipt of the request whether a TEN can be made available to you

Please note that hire of the bar area attracts a fee of £25

Apply to Suffolk Coastal District Council for a TEN.

At least 10 working days notice is required before the event

THE BAR AREA IS NOT AVAILABLE FOR HIRE UNLESS A TEMPORARY EVENT NOTICE HAS BEEN GRANTED.

REGULATIONS AND CONDITIONS OF HIRE OF BAR AREA

All the following requirements are in addition to the regulations and conditions of hire of Charsfield Village Hall. A copy of these has been given to you with the Booking form for the Hall.

- 1) The hirer shall be in possession of a Temporary Event Notice as issued by Suffolk Coastal District Council
- 2) The Temporary Event Notice shall be clearly displayed in or adjacent to the Bar Area.
- 3) The Hirer shall comply in all respects with the requirements of the Temporary Event Notice.
- 4) If a Temporary Event Notice is not granted no alcohol may be sold on the premises. In that eventuality the bar hire fee will be refunded.
- 5) All alcohol and other drinks sold from the bar area are to be provided by Charsfield Village Hall Management Committee. Stock held to be agreed before and after the event between the hirer and the Management Committee. A charge will be made for the use of the stock as agreed between the hirer and the Management Committee prior to the event.
- 6) Use of the bar area includes use of the bar fridges, glasses and sundry equipment.
- 7) It is the responsibility of the hirer to ensure compliance with all relevant legislation except in so far as it relates to the structure of the premises.
